## The challenge with managing data in a regulated environment

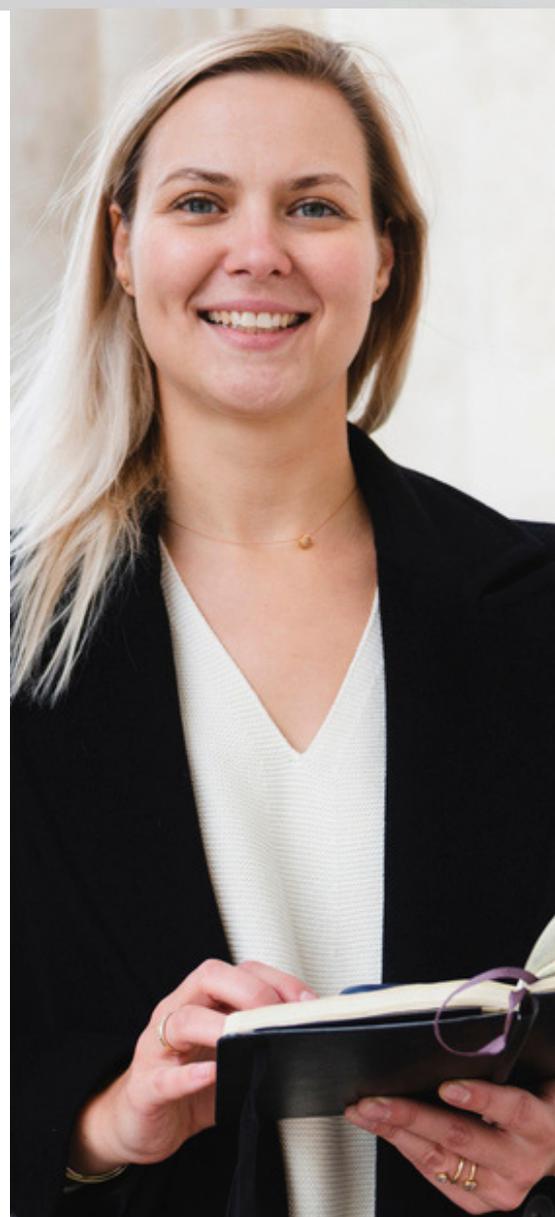
